**YOU MAY USE THIS FORM TO:**

Register to vote in a Town of Riverdale Park election or to file a change of name or address if you are already registered with the Town. The Town of Riverdale Park does not register voters by political party.

**This is NOT a voter registration application to vote in school board, county, state or national elections.**

**TO REGISTER USING THIS FORM, YOU MUST:**

- Have, or will have, the Town of Riverdale Park as your primary residence, for at least forty-five (45) days immediately prior to May 6, 2019 (March 22, 2019 to May 5, 2019);
- Be at least 16 years of age;
- Not claim the right to vote elsewhere in the United States; and
- Not to have been found by a court to be unable to communicate a desire to vote.

(2) Document that establishes current residence in the Town of Riverdale Park if not already established by (1) above. Examples could include a copy of house or apartment lease, utility bill, paycheck, bank statement, school record, or other document that shows your name and current address in the Town of Riverdale Park.

You may submit an affidavit on a form provided by the Town Clerk. Such affidavit shall be executed under the penalties of perjury.
