#### **Administration**

- Town Hall open on Wednesdays: Staff will be available to answer questions and problem solve in-person on Wednesdays from 8:30 a.m. to 5:00 p.m. starting on November 17<sup>th</sup>. The Town Hall building will be open on Wednesdays until active construction begins on the Municipal Center Renovation project and while community spread of COVID-19 remains low. Expanded walk-in hours will be implemented as the renovation project and community spread of COVID-19 permits. It is important to note that when daily cases of COVID-19 in Prince George's County for a 7-day average is at or above 15 cases per 100,00 people, Town Hall offices will close to the public. All services will continue to be available virtually.
- Town Awarded CPP Grant for Field of Dreams: The Board of Public Works recently approved the last of 31 Community Parks and Playground (CPP) projects for this fiscal year, totaling \$5 million in grants for new and upgraded outdoor facilities in communities across Maryland. The Town of Riverdale Park received \$177,750 for the Field of Dreams.

This is to give notice that the Riverdale Park Town Council has introduced and intends to take action on Ordinance 2021-OR-10.

Ordinance 2021-OR-10 would amend the adopted operating and capital improvement budget for the Town of Riverdale Park for the fiscal year beginning July 1, 2021, and ending June 30, 2022, to increase expenditures in the Town's Capital Improvement fund; and generally related to amendment of the Town's FY 2022 operating and capital improvement budget.

• Rain Check Rebate Expanded: County legislation, CB-46-2021, that expands the Rain Check Rebate Program by increasing the lifetime cap per property from \$4,000 to \$6,000 will go into effect in December.

• Weatherization programs: Programs are available to help income eligible households lower their energy bills. The Maryland Department of Housing and Community Development (DHCD) offers programs that may provide help with things like insulation, hot water system improvements, heating/cooling repair or replacement, renewable energy systems, and other health and safety enhancements free of charge. For questions or help with the application call 1-855-583-8976.

• <u>Leaf Collection:</u> Residents are encouraged to bag their leaves and/or mulch them during lawn mowing instead of pushing them into the streets. It is extremely important to keep storm drains clear of leaves to allow the system optimal performance during a rain event.

To support leaf bagging, Public Works staff have distributed ten (10) leaf bags to each single-family residence in Town. FREE leaf bags will also be available for pick up on the third Saturday of the month (9 a.m. to 2 p.m.) at the bulk trash drop off at the Public Works building until mid-January. Identification confirming residency is required.

Bagged leaves should be set out curbside by 6 a.m. on Mondays for collection by the Town's hauler. If residents choose to mulch their leaves or will otherwise not use the leaf bags, they are encouraged to give them to a neighbor.

- <u>JEDA Trucking Bulk Trash Pick-up Services:</u> As a reminder, Bulk Trash Collection is provided by appointment only on Thursdays. - Yard Waste Mondays: Yard waste collection is every Monday. Yard waste needs to be at the **curbside by 6:00 a.m.** Residents are responsible for the following items:
  - Yard waste must be placed in paper bags or reusable bins that are clearly marked "Yard Waste"
  - o Branches and limbs need to be bundled with rope or string (do not use wire), additionally all branches, limbs, and bundles must be:
    - less than 4 feet long,
    - individual branches less than 3 inches in diameter
    - weigh less than 60 pounds.
- Recycling Collection important note: The Recycling Collection Program is provided by Prince George's County. Items will not be collected if the items to be recycled are placed in any type of plastic bags. Town staff continue to receive reports that recycling items placed for pick-up are in plastic bags. Prince George's County requires that recycling be placed in a blue tote or in a reusable collection container that is clearly marked "RECYCLING" or with an "X."
   NO PLASTIC BAGS OF ANY KIND ARE TO BE INCLUDED IN THE RECYCLING CONTAINER (i.e., plastic grocery bags, plastic wrappers on soda or water containers). For additional information, please call 311 or 301-883-5810.

#### • Purple Line Updates:

Temporary Lane Closures- Update: Beginning on November 11, 2021, crews will perform underground utility work along Riverdale Road at 67<sup>th</sup> Court through December 6, 2021, weather permitting. Work may take place from 7 a.m. to 4 p.m. Monday through Friday, and as needed, on weekends. Temporary lane closures will occur. The bus stop at Riverdale

- Road and 67th Court will be closed as signed, please use the bus stop at Riverdale and 67th Place during this time.
- O Temporary Overnight Lane Closures on Kenilworth Avenue- Update: Beginning on or about July 22, 2021, crews will perform underground utility relocations overnight on Riverdale Road (MD 410) between 58th Street and Veterans Parkway (MD 410) through the end of December. Work may take place Monday through Friday 7 p.m. to 5 a.m. and on weekends, as needed. Temporary lane closures will occur.
- Temporary Lane Closure on 67th Place- Update: Crews have begun water line relocation on 67th Place through the end of December, weather permitting. Work may take place from 7 a.m. to 5 p.m. Monday through Friday, and as needed on weekends. Temporary lane closures will occur. Flagging operations will be utilized.
- O Temporary Lane Closures on Kenilworth Avenue: Crews continue performing underground utility relocations on Kenilworth Avenue (MD 201) northbound and southbound from Campus Drive to Riverdale Road (MD 410), weather permitting. Work may take place in two shifts, from 7 a.m. to 5 p.m. and 7 p.m. to 7 a.m. on weekdays and weekends, as needed. Temporary lane closures will occur with flagging operations as needed.
- O Temporary Lane Closure across the Purple Line alignment: Beginning on or about November 14, 2021, resurfacing across the Purple Line alignment will occur through mid-December. The work zones will include Riverdale Road, Kenilworth Avenue, and Haig Drive Circle. Work will occur in two shifts Monday through Friday, from 7 a.m. to 5 p.m. and as needed on weekends; temporary lane closures and uneven surfaces will occur during this effort.
- O Work Zone Safety: As work increases along the alignment, the Purple Line team remains committed to keeping everyone safe. Pedestrians and motorists are advised to follow construction signage and use the open sidewalk(s). For the safety of the public and our construction team, entry into construction work zones is not permitted.
- O Temporary Sidewalk closure: On or about November 15, 2021, the sidewalk adjacent to the College Park Bus Loop from River Road (identified in the graphic here) will be closed through December 31, 2021. Signage will be in place to guide bicyclists and pedestrians to the open sidewalk. Work may take place 5 a.m. to 7 p.m. weekdays and weekends as needed through completion of the work
- Temporary Lane Closure across the Purple Line alignment: Beginning on or about November 14, 2021, resurfacing across the Purple Line alignment will occur through mid-December. The work zone will include Campus Drive. Work will occur in two shifts Monday through Friday, and as needed on weekends; temporary lane closures and uneven surfaces will occur during this effort.



# 520 Calls for Police Service 11/23/2021 to 12/07/2021



<u>Calls for Service defined:</u> A call for service is any activity performed by a sworn police officer in the performance of their assigned duties. Calls for service covers both proactive activities such as area checks and traffic enforcement, as well as a portion of field investigative reports, traffic accidents, and response to various incidents. Calls received for dispatch are also included in the calls for service total.

Staff are working to enhance reporting capabilities to more accurately differentiate between proactive police actions and responding to dispatched incidents. The above chart illustrates that at a minimum, 208 or 40 percent of calls for service were proactive actions on the part of the Town's police officers.

Proactive Policing includes traffic safety, business and residential checks, field interviews, and quality of life issues.

Other Incidents includes disorderly complaints, fights, suspicious subjects/vehicles, parking complaints, traffic complaints, and assisting individuals.

#### Highlighted reports:

- Officers responded to the 5300 block of Quintana Street for a theft. The investigation revealed an unknown suspect removed a check from the victim's mailbox. The investigation is ongoing.
- Officers responded to the 5300 block of Lafayette Place for a suspicious vehicle. A records check revealed the 2015 GMC was reported stolen through the Prince George's County Police Department. The vehicle was impounded pending notification to the owner.
- Officers responded to a business in the 4400 block of Van Buren Street for a theft. The victim reported their wallet was stolen from inside a restaurant. The investigation is ongoing.

- Officers responded to a business in the 5300 block of Kenilworth Avenue for a trespassing complaint. An employee reported an intoxicated individual inside the business who was bothering customers and refusing to leave. The individual refused numerous requests to leave the property and was placed under arrest for trespassing.
- Officers responded to the 6100 block of Baltimore Avenue for a stolen vehicle. The investigation revealed an unknown suspect stole the victim's 2018 Dodge which was running an unattended in the parking lot. The vehicle was entered into NCIC as stolen.
- Officers responded to the 4500 block of East West Highway for a motor vehicle collision. The
  investigation revealed the operator of a Chevrolet van struck three vehicles that were stopped at
  the intersection. A records check revealed the striking vehicle was reported stolen through the
  Prince George's County Police Department. The operator was placed under arrest for motor
  vehicle theft.

#### **Updates:**

- On December 5<sup>th</sup>, the Town Police Department was made aware of a pop-up car rally event in the City of Hyattsville. The participants eventually proceeded to Route 1 and partially through our Town. The large group blocked traffic and generated numerous calls for loud noise. Town officers, with the assistance of Hyattsville City Police, Prince George's County Police, and the Maryland State Police conducted numerous traffic stops and one resulted in a DUI arrest.
- Over a several month period, numerous thefts occurred inside a business located in the 4500 block of Woodberry Street. The suspects were captured on security cameras committing similar types of thefts in multiple jurisdictions. Through investigative means the suspects have been identified and charged with a theft scheme and credit card fraud.
