Chapter 36--- Summary: Town wide Trash Collection: Monday and Thursdays. Toters must be kept in the rear of your property until placing out for pickup. Do not place toters out to the curb before sundown the day prior to collection day. Yard Waste will be collected by Bates on Wednesdays. Recycling will be collected on Wednesdays. You must call Bates and schedule Bulk pick-up.

Chapter 68---- Summary: Grass must be maintained to a height of 10inches or less.

Chapter 64--- Summary: All vehicles in the Town of Riverdale Park must be properly registered and possess current/valid registration. Vehicles in the Town of Riverdale Park, including those parked on private property, not properly registered with current/valid registration will be ticketed, and posted. If compliance is not met 72 hours after being posted, the unregistered vehicle will be impounded at the owner's expense.

### **Spring Lecture Series Kicks Off At Riversdale**

Riverdale Park – Riversdale House Museum hosts its annual Spring Lecture Series.

The two lectures scheduled for April are:

- (Rescheduled from Tuesday, March 3) Tuesday, April 28: Ann Wass, History/Museum Specialist at Riversdale, "A Great Variety of Articles Both Elegant and Useful": Antebellum American Agriculture Fairs.

Lectures are \$5 each and begin at 7:30 pm.

#### Local Artist Exhibits at Riversdale House Museum

Riverdale Park – Riversdale House Museum is proud to display the artwork of Gerald King, a realist painter and resident of Riverdale Park. Both the Riversdale House Museum and the Town of Riverdale Park serve as inspiration for a number of Mr. King's works. Gather some inspiration of your own as you view the paintings within the walls of the c. 1807 Federal mansion.

Until 1816, Rosalie Stier Calvert, the mistress of Riversdale, was the custodian for her father's collection of European masterworks paintings and displayed some on the walls of her house. Mr. King's exhibit continues this tradition. Certain displayed art will be for sale to the public. Prints will also be available in the museum shop.

The exhibit runs from Friday, April 3, to Sunday, May 31, 2009. It is open for viewing during regularly scheduled tour hours on Fridays and Sundays from noon-3:30 pm and by appointment for groups of 10 or more. Tickets include a tour of the house and cost \$3 for adults, \$2 for seniors and groups of 10 or more, \$1 for students 5-18, and free for children 4 and under.

#### Not Your Mother's Packaged Gelatin – The How and Why of Calves' Feet Jelly

Riverdale Park, MD – While enjoying a low-calorie, guilt-free cup of Jello, we rarely ponder over the fact that gelatin does not come from a convenient package found in the grocery store. The origins of gelatin begin with calves' feet. Taylor Road in full bloom: now that is gorgeous in Prince George's. With this report I'm taking Lord Polonius's advice.

This school year at Riverdale Elementary has seen the introduction of a pick up and drop- off zone, which has been effective in general but with mixed results. At its February meeting, the Traffic Study Committee and officials from our police department met with officials and representatives from the county and school to discuss ways to solve the issues at hand. One main idea suggested was a relocation of the zone to an area south of Riverdale Road along Taylor Road. Suggested was to allow parents to park along the northbound, 6000 block of Taylor Road. To allow traffic to keep moving, parking along the southbound side would be prohibited on weekdays.

Currently no parking is allowed Monday thru Friday along the northbound section and it is my desire to see that maintained and allow brief periods during at the beginning and end of the school day to allow parents to drop off and pick up their children. I'd like to thank everyone for his or her input and efforts with the school zone.

Since having been appointed to sit on the Central Kenilworth Avenue Steering Committee two meeting have been held which have entailed formulating the direction and strategy. Of the items considered has been to create a CDC similar to that created by Port Towns. I would encourage any who are interested in the development of the area to consider being involved with this group.

And with that, let me jump up on my volunteer soapbox, briefly. Earth Day is fast approaching and coming to Riverside Neighborhood Park. The Anacostia Watershed Society has designated the portion of the northeast branch and the tributaries in and around the park as one of several areas for clean up this year. As you may have read elsewhere in this edition that joining us will be several visiting officials and expatriates living in the area from our sister city Ipala. It is going to be a great day and I would ask of any and all in town to come out and lend a hand this year.

Coming a fortnight before is the annual egg hunt at the Mansion. As always, a big thanks to the Recreation Board for this and, as always, if you'd like to help out, please, don't be bashful. See you then and at Earth Day.

This workshop will teach you how to help the Anacostia and save money on your water bill.

Barry Chenkin of Aquabarrels will be our resource person. Michael Sevener, Riverdale citizen and forward-thinking engineer, will offer a perspective on the increasing importance of harvesting rainwater.

## Coming Soon: Arts Fest 2!

The Riverdale Park Arts Council (RPAC) is moving full steam ahead planning for ArtsFest 2 scheduled for Sunday, May 3, 2009 at Town Center next to the MARC station. As you may recall, the first ArtsFest held on May 4, 2008 was a major success with nearly one-thousand adults and children attending. This year promises to be even better. Here are some of the plans that are underway.

Melissa Avery and Don Lynch are planning the live entertainment and have scheduled some spectacular groups to perform at ArtsFest 2. These include: Rick Franklin (acoustic blues); Mariana

Previti (three-time WAMA Jazz Vocalist, singing R&B); Honky Tonk Heart (Classic Country & Western Swing); Ira Gonzalez and award winning Saxophonist and Lyle Link (Brazilian bossa nova); Janine Wilson (current WAMA roots rock vocalist) and Max Evans (Contemporary Blues); and Eric Brooks (jazz standards). Sound will be provided by Jamie Platt who provides sound at Glen Echo. In addition, Melissa and Don are researching a theater group, Active Culture, and their performance called Sportaculture. Active Cultures Theatre presents Sportaculture-a festival of short plays about sports. These five slightly goofy plays by local sports fans Jennifer Nelson, Mary Watters, James Hesla, and others will show you athletes and fans as you never seen them before. This is an hour-long performance as that cele-

brates three things we love-sports, theatre, and the great area in which we live. Warning: this performance is only recommended for die-hard sports fans, people with silly bones, adults with children, adults who don't have children, serious athletes and anyone who has ever had a P.E. class.

The RPAC will be fund raising for the Thai Elephant Conservation Center (TECC) and RPAC by selling the paintings done by real elephant artists from the Thai Elephant Academic Art Academy in Lampang, Thailand, and other products created by their caretakers. TECC is funded by donations and is subsidized by the Thai government with strict rules on the handling of the animals. The elephant's caretakers

(mahouts) and their families give up all worldly possessions and dedicate their lives to caring for these elephants on the preserves. The mahouts and families hand make greetings cards and stationery from recycled elephant



dung. When you purchase these paper products from RPAC, you are helping these families with money for clothing, school supplies, repairs to their grass roofs, and other everyday items. Come see the Elephant Art Gallery and see the elephant art for sale. The gallery shows elephant art, the elephant's artistic development in the Art Academy. A CD demos the actual elephants painting on TECC grounds, the elephant's care by manhouts, and a real Elephant Orchestra playing music in the background. Emily and Del Fanning, who visited Lampang and the elephants and participated in mahouts training, will be showing the elephant art.

Marc Molino is working to enlist various artists who will participate in ArtsFest 2, and Jim Coleman and Pat Gladdings are working on the Gallery Display. In addition, once again their will be a Children's Pavilion which was wildly popular last year. This year we will promote art projects that can be undertaken by children ages 2-12. We need help in implementing the various art projects we will undertake with the children. So consider getting involved with your children.

## **Cherry Blossom Festival**

groups in the Nation's Capital.

The National Cherry Blossom Festival® annually commemorates the 1912 gift of 3,000 cherry trees from Mayor Yukio Ozaki of Tokyo to the city of Washington, honoring the lasting friendship between the United States and Japan and celebrating the continued close relationship between our two cultures.

In a simple ceremony on March 27, 1912, First Lady Helen Herron Taft and Viscountess Chinda, wife of the Japanese ambassador, planted the first two trees from Japan on the north bank of the Tidal Basin in West Potomac Park. In 1915, the United States Government reciprocated with a gift of flowering dogwood trees to the people of Japan. A group of American school children reenacted the initial planting in 1927 and the first "festival" was held in 1935, sponsored by civic

First Lady Lady Bird Johnson accepted 3,800 more trees in 1965. In 1981, the cycle of giving came full circle. Japanese horticulturists were given cuttings from our trees to replace some cherry trees in Japan which had been destroyed in a flood.

The Festival was expanded to two weeks in 1994 to accommodate a diverse activity schedule during the trees' blooming. Today, more than a million people visit Washington, DC each year to admire the blossoming cherry trees and attend events that herald the beginning of spring in the Nation's Capital.

The Festival looks forward to celebrating the centennial anniversary of the gift of trees in 2012 and is planning spectacular events to mark this historic and special occasion (http://nationalcherryblossomfestival.org).

The Cherry Blosssom Festival is happening right now between March 28 and April 12 in D.C. on the Tidal Basin. If you're looking for something to do as we ease into spring, head on down and take part in the free events!

### **Earth Day**

Responding to widespread environmental degradation, Gaylord Nelson, a United States Senator from Wisconsin, called for an environmental teach-in, or Earth Day, to be held on April 22, 1970. Over 20 million people participated that year, and Earth Day is now observed each year on April 22 by more than 500 million people and national governments in 175 countries.

Senator Nelson, an environmental activist, took a leading role in organizing the celebration, hoping to demonstrate popular political support for an environmental agenda.

Earth Day proved popular in the United States and around the world. The first Earth Day had participants and celebrants in two thousand colleges and universities, roughly ten thousand primary and



secondary schools, and hundreds of communities across the United States. More importantly, it "brought 20 million Americans out into the spring sunshine for peaceful demonstrations in favor of environmental reform."

Senator Nelson stated that

Earth Day "worked" because of the spontaneous response at the grassroots level. Twenty-million demonstrators and thousands of schools and local communities participated. He directly credited the first Earth Day with persuading U.S. politicians that environmental legislation had a substantial, lasting constituency. Many important laws were passed by the Congress in the wake of the 1970 Earth Day, including the Clean Air Act and the creation of the United States Environmental Protection Agency.

It is now observed in 175 countries, and coordinated by the nonprofit Earth Day Network, according to whom Earth Day is now "the largest secular holiday in the world, celebrated by more than a half billion people every year." Environmental groups have sought to make Earth Day into a day of action which changes human behavior and provokes policy changes.

Many cities extend the Earth Day celebration to be an entire week, usually starting on April 16, and ending on Earth Day, April 22.

People can do their part in making a difference by:

- 1. Encouraging your family to recycle on a regular basis is a good way to help the Earth!
- 2. Switching to energy-efficient lightbulbs in your house helps to reduce the effects of global warming.
- 3. Every glass bottle you recycle saves enough energy to run a TV for an hour and a half, while recycling an aluminum can saves enough energy to run your TV for three hours!
- 4. Turn out the lights when you leave a room unless someone's still in there!
- 5. Use re-useable containers for you school lunches and snacks
