This .0350 tax rate increase is proposed to fund Walk, Bike, and Drive specific projects in FY2025.


This tax rate increase is projected to yield an additional \$351,435.









The FY2025 Budget assumes an increase in the Multifamily Rental License fee from \$115 to \$125 per unit.
